Due attention is given to United States Navy actions under Commodore David Porter, to this day a subject of controversy. More significantly though, through the juxtaposition of British, American and Spanish sources, this book uncovers the roots of piracy – and suppression – that laid the foundation for the tortured decline of the Spanish empire in the Americas and the subsequent rise of British and American empires, instrumental in stamping out Caribbean piracy for good.

Originally published in 1824, this firsthand account describes how, in June 1822, young English seaman Aaron Smith was taken captive by Cuban pirates when his ship was boarded en route from Jamaica to England. A skilled navigator, fluent in Spanish, and regarded as what was then acceptable as a ship's surgeon, he was an attractive candidate for conscription. Forced to work as a navigator and participate in pirate boarding parties for ten months, he suffered mightily and witnessed unspeakable acts of murder and torture. He struggled between resisting the orders of the cruel pirate captain and acting against his conscience to preserve his own life from the wrath of the pirates. After failed attempts to get away, he managed to narrowly escape with his life, but was arrested as a pirate upon arrival in Havana. Smith was jailed in Cuba and then sent back to England in chains, where he found himself on trial for his life at the Old Bailey courthouse. The attorney general himself led the prosecution, with the captains of the ships boarded by Smith and the pirates as the principal witnesses.

In the years before the Civil War, many Americans saw the sea as a world apart, an often violent and insular culture governed by its own definitions of honor and ruled by its own authorities. The truth, however, is that legal cases that originated at sea had a tendency to come ashore and force the national government to address questions about personal honor, dignity, the rights of labor, and the meaning and privileges of citizenship, often for the first time. By examining how and why merchant seamen and their officers came into contact with the law, Matthew Taylor Raffety exposes the complex relationship between brutal crimes committed at sea and the development of a legal consciousness within both the judiciary and among seafarers in this period. The Republic Afloat tracks how seamen conceived of themselves as individuals and how they defined their place within the United States. Of interest to historians of labor, law, maritime culture, and national identity in the early republic, Raffety's work reveals much about the ways that merchant seamen sought to articulate the ideals of freedom and citizenship before the courts of the land—and how they helped to shape the laws of the young republic.
