"I have no dress except the one I wear every day. If you are going to be kind enough to give me one, please let it be practical and dark so that I can put it on afterwards to go to the laboratory", said Marie Curie about her wedding dress. According to her lecture notes, Gertrude B. Elion is quoted a few decades later: "Don't be afraid of hard work. Don't let others discourage you, or tell you that you can't do it. In my day I was told women didn't go into chemistry. I saw no reason why we couldn't." These two quotations from famous, Nobel Prize winning chemists amply demonstrate the challenges that female

Biotechnology in Surgery - Alfonso Barbarisi 2010-12-28

The 20th century has finished, the century when surgery took huge steps forward thanks to progress in technology. Now we have entered the "century of biotechnologies", which will not only generate progress in surgery, but also lead to a real "cultural revolution" that will completely change approaches to solving different problems in medicine. The aim of this book is to bring surgeons closer to biotechnologies and to overcome the cultural gap dividing them from these new approaches. Biotechnologies are already proposed and used

at different levels in surgical practice: in diagnostic technique, enabling practitioners to identify diseases at an early stage and follow their molecular modification over time; and in tissue engineering, where the use of "smart scaffolds" offers a possible answer to increasing demand for biocompatible tissues and organs in transplantation surgery. This volume focuses on the emerging field of stem cells, analyzing both their role as possible players in originating and perpetuating cancer - "cancer stem cells" - and, conversely, their extraordinary therapeutical potential. An additional section is dedicated to the evaluation and application of derived molecular factors that can enhance the physiological processes that are fundamentally important in surgery, such as hemostasis and wound healing. Surgeons have always been technologists, in the sense that since surgery began they have always needed technology, beginning with a scalpel and surgical instruments. They have always cooperated with technologists. However, in the new century, the first one of the millennium, a rapid increase in knowledge that is outside the realm of the surgeon's traditional technological training is imposing itself - hence the aim of this book. It is now urgent to encourage surgeons to embrace this knowledge (biotechnology) with confidence. By its very nature, biotechnology is completely different from the technologies used so far, because it escapes the senses of sight and touch, which up to now have been the essence of the surgeon's work. The cellular and molecular dimensions of biotechnologies are still far removed from most of the recent advances in modern surgical techniques. A common language between surgeons and biotechnologists will create further, revolutionary, progress in surgical sciences in the twenty-first century.

The Fall of the House of Usher - Edgar Allan Poe 2021-08-19

The Fall of the House of Usher Edgar Allan Poe - Roderick Usher is ill, but not due to any normal causes. When the narrator of the story arrives at the House of Usher, he finds that all is not well in the old ancestral home. The house itself appears to be almost alive, and the illness of Madeline, Roderick's sister, is not all it seems. The Fall of the House of Usher by Edgar

Allan Poe is a classic short story first in 1839, and was memorably adapted for film by Roger Corman in 1960. The Fall of the House of Usher is in the opinion of many scholars Poe's most famous work of prose. This unsettling macabre work is viewed as a masterpiece of American Gothic literature. Indeed, as in many of his tales, Poe borrows much from the Gothic tradition. Still, as G. R. Thomson writes in his Introduction to Great Short Works of Edgar Allan Poe: "the tale has long been hailed as a masterpiece of Gothic horror; it is also a masterpiece of dramatic irony and structural symbolism." The Fall of the House of Usher has also been criticized for being too formulaic. Poe was criticized for following his own patterns established in works like Morella and Ligeia using stock characters in stock scenes and situations. Repetitive themes like an unidentifiable disease, madness, and resurrection are also criticized. However, there is speculation that Poe used a real-life incident as the basis for his story: the entombment of two lovers at Usher House in Boston, whose bodies were discovered when the house was demolished in 1800. Scholars speculate that Poe, who was an influence on Herman Melville, inspired the character of Ahab in Melville's novel Moby-Dick. John McAleer maintained that the idea for "objectifying Ahab's flawed character" came from the "evocative force" of Poe's The Fall of the House of Usher. In both Ahab and the house of Usher, the appearance of fundamental soundness is visibly flawed by Ahab's livid scar, and by the fissure in the masonry of Usher.

Stylish and dark, the BBC series the 'Peaky Blinders' is set in the backstreets of Birmingham after the First World War and tells of the rise to power of Thomas Shelby and his criminal gang. Yet the real stories behind these fictional characters are just as dramatic, bloody and compelling as the TV series. Thomas Shelby's arch enemy Billy Kimber was in real life a Brummie from Summer Lane. He was a feared fighter with an astute mind and magnetic personality which earned him the leadership of the Birmingham Gang that dominated the highly profitable protection rackets of the racecourses of England. The members of this gang had once been 'sloggers' or 'peaky blinders' and their rise to supremacy was attributable to their viciousness and to Kimber's shrewd alliances with other gangs. But they soon incurred the envy of the Sabini Gang of London who fought violently to oust Kimber and his men and take over their rackets. The Birmingham Gang battled back fiercely in the infamous and blood-stained racecourse wars of the 1920s. This Birmingham Gang led by Billy Kimber were the Real Peaky Blinders and this is their story.
